City Leaders Do Lunch With Business Folks They Talk Traffic and Taxes

Tallahassee city commissioners took their show on the road Tuesday, meeting with north-side business leaders in a roundtable discussion on issues from bus/bike lanes on West Tennessee Street to their own priorities.

Taking part in the luncheon meeting at the Monroe Street Conference Center with the North East Business Association were Commissioners Andrew Gillum, Nancy Miller, Mark Mustian and Gil Ziffer. Mayor John Marks did not attend.

NEBA has been known for criticizing City Hall over tax hikes and other issues. But the meeting began with a thank-you from Mark Trafton, president of NEBA, for the city's recent return of millions of dollars in utility deposits to commercial customers.

"We all know that in this business climate, a lot of folks are in a tough financial position," Trafton said. "It was a great gesture, and we needed it."

Commissioners expressed general support for a pilot project to convert outside lanes of West Tennessee from Monroe to Ocala streets to bicycle and bus lanes. They said the proposal for the six-lane road is designed to slow down traffic near Florida State University and make the area safer and more efficient for walkers, bikers and drivers.

But some NEBA members were skeptical.

"Somebody will get killed — you just wait and see," said Ray Munroe of Mays-Munroe appliances.

Ziffer said he supports the change because he believes it will speed up bus traffic and improve pedestrian safety. However, he said he's worried about bicyclist safety under the change.

"Typically, cars don't look for bikes, and that concerns me," he said.

Mustian emphasized that cars will still be able to make right turns into businesses. And Miller said traffic analyses show the change would probably move vehicles through more efficiently. Gillum said he hopes to create a vital university atmosphere that people don't "race through." Commissioners are expected to vote on the proposal next month.

NEBA member Peggy Munroe asked about deferred compensation, a retirement benefit the City Commission voted to give itself in 2005 before Miller or Ziffer took office. Several former and current commissioners got between \$80,000 and \$105,000 in their retirement accounts before the commission later voted to end the practice. Ziffer got a much smaller amount, about \$7,600. Miller got none.

Mustian said he'll be giving his to charity once he leaves office at the end of his term later this year. Ziffer said he'll be giving his back, too. Gillum suggested he would make a charitable donation once he reaches retirement age or leaves city government. He and Mustian said the money can't be returned before then without facing a tax penalty.

On their priorities, Mustian said his goal is to leave the government in better financial shape than when he became a commissioner, something he's not sure will happen given project deficits.


"We're going to have to do some things — either cut some programs people like or raise taxes," Mustian said. "And I think I know where you guys are on that and that's kind of where I am, too."

Gillum said his priority is economic development, particularly downtown. Miller said hers is infrastructure, from roads to water and sewer. Ziffer said in addition to transportation, he wants to focus on arts and culture, which he said were important economic-development drivers.

Ziffer said inclusion of a proposed performing-arts center on a list of projects to receive sales-tax proceeds is iffy. He said he wants to work on a new cultural plan that doesn't have "extremely expensive" proposals.

"Distressed" Residential Real Estate Sales in Leon County

Distressed sales in Leon County have skyrocketed since 2008. A "distressed" sale is defined as a short sale (where seller's lender accepts a payoff that is less than the amount owed on the property), foreclosure sale or the sale of a bank owned property. These types of sales have increased from 27 in 2008 to 793 in 2011. The percentages of "distressed" sales have increased accordingly, 1% of total sales were distressed in 2008, 9% in 2009, 26% in 2010 and a whopping 34% in 2011!

Identity Theft: Protecting Yourself

How it Happens

Identity thieves get information in a variety of ways, including:

- Stealing personal items such as a wallet, purse, laptop, personal digital assistant and/ or mail
- Picking through garbage for discarded credit card statements, bank statements, and preapproved credit card offers, etc.
- Hacking into computers.
- Posing as someone else to obtain personal information from a bank, credit card company, etc.
- Conducting telephone and e-mail scams.

Report Identity Theft

If your wallet or some of its contents are stolen:

- Determine what's been stolen, and call all creditors immediately to cancel your accounts.
- File a police report. This will help provide proof of immediate action to your credit card providers.
- Call the three national credit reporting bureaus, as well as the Social Security Administration, so that a fraud alert can be placed on your name and Social Security number.

The U.S. Federal Trade Commission reports that over 12 million people are victims of identity theft every year.
