## Robert Parrish Addresses NEBA

Robert Parrish, head of the Parrish Group developers and past president of the Florida Builders Association, addressed NEBA on Nov. 11 on the challenges facing the construction industry in Tallahassee and across Florida.

“I’m not a gloom and doom guy,” Parrish stressed at the outset. “There’s opportunity everywhere.”

He noted that we are blessed to live in Tallahassee, where the impact of the economic downturn is less than in other areas.

“From Tampa south it is dead man’s land,” he said. “\$80,000 lots are being offered for \$20,000, and there are no buyers.”

Parrish believes the best strategy is to “stick close to

home,” focusing on opportunities in Tallahassee rather than elsewhere. He said that’s what he intends to do now that he’s not heading the Florida

panding urban sprawl. Housing simply got out of hand” he said. “But conditions today favor a more conservative lifestyle, one more



Builders Association, which kept him away much of the time. Additionally, while his firm has concentrated on commercial property development, he sees opportunities in the residential area and may renter it.

However, he sees the housing opportunity being in smaller, more affordable homes probably located more toward the city center than the suburbs.

“For 20 years every home built went up in size, most of them ex-

neighborhood oriented.” He recalled growing up in a 1,400 sq. ft. home in Augusta, GA, which in his mind was adequate for a happy

existence. In his opinion, there'll be demand for smaller homes, just as there is for smaller, more fuel efficient automobiles.

Parrish noted his office developments at the intersection of Fleischman Road and the Welaunee extension of Blair Stone Road, plus the building going up in the Metropolitan Corporate Center at Thomasville and Interstate 10. He said efforts were underway to modify the city's zoning codes to permit more retail space in such developments.

“We need a restaurant in Metropolitan so that the people working in those offices don't have to get out on Thomasville or Capital Circle at noon to get lunch,” Parrish said.

In his view, all developments should include service facilities.

Too often, he said, opponents such as neighborhood associations oppose this concept for fear it will attract, rather than reduce, traffic. Zoning regulations, unfortunately, tend to support such fears.

“If we don't start doing something to help developers expand our tax base, Tallahassee is going to become an expensive place to live,” he warns, adding that “we are perhaps the worst regulated city in the state.”

As for the current economic situation, Parrish feels it will prevail through 2009, when things hopefully will improve. Meantime, the state may have to dip into reserve funds to meet its needs, and some layoffs of state workers are a possibility. But he remains optimistic that Tallahassee will be the first to benefit from better times when they return.
