City Manager: Everything is on the Table

allahassee city manager Rick Fernandez, who served as assistant manager over utilities for 17 years and city auditor for 10 years, was appointed to his current position on November 21, 2015. A native of Cuba, he was raised in New York City, and has been a CPA since 1982.

Mr. Fernandez emphasized that "everything is on the table" as he assesses better ways to run the city, with emphasis

on best practices and transparency. He referred to his recent organizational restructuring, which eliminated three departments and 10 managerial positions, as a positive move that has been well received.

In an effort to prevent some of the objections raised during the last budget process, Fernandez intends to provide quarterly budget updates to the commissioners. The city administration

was scheduled to undergo an exercise by three representatives from the Governmental Finance Officers Association to review the city's budget process and recommend best practices. This review included assessing what is an appropriate level of funding for the city's reserve fund.

He took questions from the audience and thanked NEBA for inviting him, adding that he welcomes any and all input from the community.

Alex Baker: New Vision for the Old Tallahassee Mall

he February 23 meeting featured Alex Baker, CEO of Blackwater Resources. Blackwater is the developer of the Centre of Tallahassee in the location of the former Tallahassee Mall. Blackwater Resources has developed 34 million square feet of property in 36 states and four countries.

Tallahassee Mall is the fourth "dead mall" Blackwater has revitalized. The Centre of Tallahassee sits on 97 acres, with 841,000 of retail square feet. 350 apartments targeting young tenants will be located above the retail area. Construction on a limited service boutique hotel will begin in the fourth quarter of this year. The School of Arts and Sciences is currently

under construction on the second floor of the former Dillard's store (Gayfer's to those of us who have lived here a long time).

The Centre will offer an Urban Food Market that will include five restaurants with a variety of food offerings, including fine Italian cuisine. The restaurants will share a 500 seat dining area. This allows people to dine together but order food from different restaurants. Another restaurant, Dreamland Barbeque, will open in May.

The Centre includes a 10,000 seat amphitheater with three performances

scheduled in April. Baker promised that two shows that will be held on consecutive days will bring 17,000 people to the area in a two day period. To handle the anticipated parking challenges, the Centre will offer an app to inform patrons of the locations of vacant parking spaces.



The Candidates for State Attorney Discuss Their Plans

he March 22 meeting featured the three candidates for State Attorney: Jack Campbell, Sean Desmond, and Pete Williams. Campbell and Desmond will face off in the Democratic primary in August. Williams, a Republican, will face the primary winner in November.



Campbell graduated from Samford-Cumberland School of Law. He emphasized his 15 years in the state attorney's office, which includes trying 20 homicide cases. Campbell believes his relationships with law enforcement and the community are an important part of the job.

He warned the audience that internal people in businesses can be criminals, and he would assist businesses with this problem. He believes the office should go paperless to cut costs. His special interest is child sexual abuse, which is now initiated through the internet. If elected, Campbell promised to have an open ear and open heart.



Sean Desmond

Desmond graduated from Florida State University College of Law. He has worked the criminal justice system from both sides: as a prosecutor and as a criminal defense lawyer. He said the most important thing he would bring to the job

is what he learned while working from the other side. Desmond said he would have "the guts to say no, even to law enforcement." If elected, he would reallocate more

resources toward violent crime and work to prevent young people from becoming criminals for life. He would work to reduce the high turnover of prosecutors.



Williams graduated from the University of Florida College of Law. In addition to working as an assistant state attorney, Williams served as the Statewide Prosecutor under Attornev General Charlie Crist. He believes too many frivolous cases in the state attorney's office are taken to trial. He would use more pre-trial diversions, drug court, and faith-based programs. He promised to treat people the same, adding that minorities are currently being treated differently. If elected, he would implement a code of ethics that the state attorney cannot solicit contributions from attorneys who work in the office.

Campbell won the straw poll, with Williams placing second and Desmond placing third.


