Tax Collector Candidates Square Off; Jim Messer Gives His Vision for House District 9

he final candidate forum was held on October 25, featuring the candidates for Leon County Tax Collector and Florida House of Representatives District 9.

Incumbent Tax Collector Doris Maloy (D) was challenged by John Paul Bailey (R). Mrs. Maloy stressed her accounting and MBA degrees and the improvements

she made during her 16 years in office. Mr. Bailey stressed his public service as a police officer and city commissioner, emphasizing the value of his budget experience. He stated that he would improve customer service in the office by offering apps, a popular payment method for young people. Mrs. Maloy won the NEBA straw poll and won the election on November 8.

House District 9 candidate Jim Messer (R) explained the advantage of having a representative in the Florida House in the majority party. Because District 9 representatives

The meeting program was a panel discussion about business issues in the upcoming legislative session. The panelists

were Bill Herrle, Executive Director of National Federation of Independent Business (NFIB); Dominic Calabro, CEO Florida TaxWatch; and Brewster Bevis, Senior Vice President for State and Federal Affairs of Associated Industries of Florida (AIF). The moderator was Nancy Smith of Sunshine State News. Mr. Calabro raised the issue of Florida being the only state with a tax on business rent. However, Speaker Richard Corcoran's current concerns about a potential budget deficit may make tax cuts difficult. The panelists agreed that Governor Scott's request for \$85 million for economic development will likely be blocked by the Speaker.

Mr. Bevis explained that Speaker Corcoran will require all legislative member projects to be stand-alone bills. Senators will have to get House sponsors for their member projects.

The hottest topic was a 14.5 percent increase in workers' compensation rates. The increase was challenged in the courts and is under appeal at the time of this writing. Mr. Herrle and Mr. Bevis said that court rulings declaring caps on attorney fees to be unconstitutional were the reason for the increase. They believe a legislative fix is necessary.

Several opinions were expressed about Obamacare, including the potential

for Medicaid block grants to the states and more market-driven proposals. AIF and NFIB took no position on medical marijuana. TaxWatch opposed it. All panelists oppose a minimum wage increase. State worker pay raises are not a high priority of their organizations, and they made no predictions. They agreed that automobile PIP should not be repealed.

In closing, the panel encouraged the audience to meet with their legislators and express their opinions on business issues. They stressed the fact that legislators listen to their constituents.
